- 4. Report from Chair Board Chair, Jordan Watters
 - Appreciation for the work of SCBC. Acknowledging the role of the interim ED,
 Fiona Douglas-Crampton. Appreciation to staff for rolling with the changes.

- Report from the Executive Director Interim Executive Director, Fiona Douglas-Crampton
 - Focused on listening and learning and nurturing the roots of the
 organization. First activity was to meet all the staff and board. During these
 meetings, she drew out three themes: clarity, compassion, and connection.
 Staff are incredibly caring and connected with each other. Will continue to
 nurture that through team activities out in nature, and having office space
 to meet in person. Have rented office space in a co-working space in
 Vancouver.

- Activities: Overseeing salary review and finalizing the strategic plan. In fund development, continuing to develop new partnerships. Excited about the work the team is doing.
- Campaigns Update Director of Campaigns and Programs, Shelley Luce
 - 30 by 30: Work on 30% protection by 2030 is progressing slowly. Only 5 years left to achieve another 15% from where we are. Need to work together.
 - Biodiversity campaign: So important because it represents protection for all beings in the rest of the 70%.
 - Climate change: Connecting the dots on how fossil fuels and poor forestry practices are making wildfires much worse. Shared the message on a webinar for which 1000 registrations.
 - Mother Tree Local leaders program: Garners deep commitment leading to deep change and networked effects.
- 7. Education Update Education Lead, Kate Sotelo
 - Prioritize: Inquiry based, land-based, and place-based.
 - Always blending western science and indigenous connections.
- 8. Treasurer's Report Treasurer, Rob Gillezeau
 - Strong fiscal position. 2023 was not an easy year for non-profits. Transition period coming off the supports of the pandemic and at a time of high inflation. Even with a tightening of the fiscal context, the numbers still balance. Compared with 2022, revenues declined. Revenues fell from 3.6 to 2.9 million. While expenses were brought from 3.2 to 2.8. Surplus declined from \$392K to \$70K, but that is normal and can be seen as the right spot for this type of organization. With respect to our broader financial picture, we are in great shape. Assets of 2.7 million, outstripping liabilities by 1.1 million.
