Subject: Safeguarding thriving ecosystem relationships through a new biodiversity and ecosystem health law

Dear Minister Neill:

Close to 8,000 British Columbian organizations and individuals weighed in on BC's draft Biodiversity and Ecosystem Health (BEH) Framework, released in November 2023 and a key step for implementing the 2020 independent Old Growth Strategic Review. These commitments were made in response to huge support for protection of old growth and other endangered ecosystems in recent years, and people and groups like ours who have participated are eager to see change on the ground.

We write today to urge BC to continue this important work and move forward on implementing the BEH Framework, including launching a robust co-development process for a new law that ensures biodiversity and ecosystem health are prioritized and which is consistent with the *UN Declaration on the Rights of Indigenous Peoples*.

It has been more than a year since the public comment period on the draft BEH Framework closed, following thousands of mostly positive comments. We celebrated the BC government's commitment in the Framework to the conservation and management of ecosystem health and biodiversity "as an overarching priority" and to "formalize this priority through legislation and other enabling tools that apply to, and can be accessed by, all sectors." We look forward to continuing our celebration of this work as the Framework is finalized and implemented through a new law.

We strongly support the paradigm shift envisioned by the Old Growth Strategic Review and the BEH Framework, described in the Framework as:

"[A] transformational shift from a land management system that prioritizes resource extraction (subject to constraints) to a future that is proactive, prioritizes the conservation and management of ecosystem health and biodiversity, and is implemented jointly with title and rights holders."

Your government's commitment to legislation enshrining this prioritization is critical. A biodiversity and ecosystem law is essential to provide the certainty and predictability we all need on the landscape. We fully agree with the Premier that measures to address the US tariff threat cannot come at the expense of our environment or reconciliation commitments. Now more than ever we need to protect what we love, preserve future economic opportunities, and ensure the security of our communities.

Doing so will also require immediate, on-the-ground measures to implement the BEH prioritization to maintain options for the future; this includes effective measures to ensure that rare and at-risk ecosystems (e.g., old growth) remain intact while negotiations and engagement processes are ongoing.

We look forward to working with BC, First Nations governments, western and Indigenous scientific experts, diverse stakeholders and local communities to shape the new biodiversity and ecosystem health law.
